Tax Organizers

Tax Filing Deadline Dates

Tax season is busy. If you want your work to be filed before 4/15, you need to get your materials out to us by March 20. Remember, if you are a corporation or business you may need to **issue 1099s or W2s by January 31** as well as **file any quarterly payroll** work. You also need to get your **partnership/corporate returns completed by March 15.** Personal returns are due April 15.

Changes for 2009 Taxes!

Sales tax break for people who don't itemize. If you pay sales tax on a new car but don't itemize on Schedule A, your standard deduction is increased.

1st Time Homebuyers get an \$8000 gift from Uncle Sam

Sales Tax is still deductible this year. Save your receipts for me if you buy a car, boat, or RV.

Capital Gains rates increase in 2011. Sell your hot stocks in 2010 to avoid the tax.

Auto Mileage rate is 55 cents/mile

Plug In Electrical Cars - get a tax break if you buy one.

Roth IRA's. Convert your Roth IRA in 2010 and stretch the tax impact over more than one year
